**APPLICATION CRITERIA AND RULES:**

- Each applicant must submit a completed application form indicating their proposed menu and electrical requirements.
- Vendor selection is at the discretion of the One World Committee. The committee will select vendors in the best interests of the festival.
- Vendor placement will be made by the One World Committee.
- The Vendor Application Form needs to be signed and submitted.
- Vendors will be responsible for obtaining a Lake County Health Department Temporary Food Service Permit. Information will be provided once your application has been accepted. It is the vendor's responsibility to submit the proper paperwork to the Health Department.
- Each vendor is responsible for cleanup of space at the end of the festival.
- Insurance Coverage: Each vendor must provide an insurance certificate reading as follows: *"The Village of Mundelein, Mundelein Community Connection, Fremont Library District, Santa Maria del Popolo and Mundelein Parks & Recreation District additional insured for products liability and public liability."* This is due by September 8, 2016. If a Certificate of Insurance has not been provided the business will not be allowed to open.
- One parking space will be assigned per vendor. No other vehicles will be permitted within the barricaded areas.
- Set up may begin after 8 a.m. on the day of the event.
- Set up must be completed and all unnecessary vehicles will be removed from the vendor area by 10:30 a.m. on the day of the event.
- The One World Festival will open from 11 a.m. to 3:30 p.m. on September 17, 2016.
