

# POLICY OF PARTICIAPTION

The Mundelein Fire Department Citizen's Fire Academy is a program to allow the residents of Mundelein to learn about the fire service particularly the Mundelein Fire Department. The following parameters will be followed in the selection of the academy participants.

- 1) The applicant(s) must meet one of the following:
  - a) Be a resident of the Village of Mundelein
  - b) Own a business in the Village of Mundelein
  - c) Work in the Village of Mundelein.
  - d) Be a family member of a Village of Mundelein employee.
  - e) Be a student of Mundelein High School or Carmel High School.

Citizens Fire Academy participants will be based on the status of the applicant and the discretion of the Mundelein Fire Department.

- 2) A minimum age of 18 is required to be accepted into the program.
- 3) The applicant must supply a brief medical background.
- 4) A background check will be performed by the Mundelein Police Department along with a driver's license check of each applicant.
- 5) The Mundelein Fire Department reserves the right to:
  - a) Reject any applicant.
  - b) Terminate student participation

The participant hereby consents and agrees in furtherance its obligation under the terms of the agreement to defend the Mundelein Fire Department, the Village of Mundelein, Illinois and its officers and employees against all suits, claims, demands and actions growing out of his or her participation in the activities of the Mundelein Fire Department.
